
The college has implemented e-Governance in AY 2005-06 for paperless work culture, efficiency in processes and strengthening of ICT. The areas of e-governance are:

 - a) IQAC recommended to the strengthening of e-governance [Ref: IQAC Meeting 14/02/2008; Agenda point No. 5 & 6].
 - b) The decision taken in the IQAC meeting was discussed and approved in the CDC meeting [CDC Meeting; 26/11/2008, Agenda Point No. 3(D), Page-51(47-54)] AY 2008-09). The provision of budget for the effective implementation of e governance of Rs. 5,00,000/- (Five lakhs rupees) has been made.
 - c) Thereafter the e-governance is employed using VRIDDHI Software, SOUL

Software in the field of administration, finance and accounts, student admission and support, examination for each year.

- d) The expenses against e-governance are reflected in the form purchase of hardwares, tools, softwares, installation and maintenances.
- e) For procurement of software the quotations from various firms (VRIDDHI, Arihant) were obtained, accordingly the lowest quotation is approved for purchase and procurement, and VRIDDHI Software from the firm is installed. (Quotations obtained from various firms are mentioned in following sections).
- f) In AY 2015-16, SPPU, Pune also recommended to use VRIDDHI ERP software for ease in administration, admissions, finance, examinations and student support.
- g) VRIDDHI ERP Software is updated and upgraded in February 2016. The expenditure made is clearly reflected in the audited statement attached [Bill Date: 02/02/2016, Payment No: 460, Date: 22/03/2016, Cheque No: 86728 on Ahmednagar District Co-operative Bank] and highlighted [Ref. No. Cash Book, AY 2015-16 (No.4, A] for the said purchase. These details are already mentioned in SSR under 6.2.2.




Maintenance Bills






